BARREL OF GOLD FUTURITY BBI SIDEPOT FOR FUTURITY AGE ELIGIBLE HORSES.

BRN4D OPEN BBI SIDEPOT FOR DERBY AGE ELIGIBLE HORSES.

FUTURITY RULES AND REGULATIONS:

1. THE BARREL OF GOLD FUTURITY is open to horses foaled in 2004 and 2005 (4 and 5 years of age). Horses must never have competed in any barrel race including, but not limited to, registered shows, open shows, playdays, rodeos or other futurities prior to December 1, 2008.

2. Age of horse is determined as of January 1 of calendar year foaled. Photocopy of registration (FRONT & BACK) or veterinarian's affidavit of year of birth and complete description of unregistered horses must accompany nomination in futurity. All horses are subject to veterinary inspection and management reserves the right to reject any questionable entry. Substitutions allowed only in the event of unsoundness, illness or death of nominated horse. A \$50 office charge will be assessed. Veterinarian's affidavit of proof must accompany substitutions.

3. AMATEUR DIVISION: Entries must be entered in the futurity and will follow all futurity rules. Payment of \$60 must be made by August 1 to enter the amateur division. Contestants cannot have previously won the amateur division and must not have more than \$500 won in futurities in lifetime prior to January 1 of the current year. Amateur placings will be determined by the average of the futurity. Payout will follow futurity payout schedule.

4. THERE WILL BE TWO GOES. The first go will be Saturday, August 29, at 9am. The second go will be Sunday, August 30, at 9am. There is a 5-second penalty for each knocked over barrel. Total time of the two goes will determine the average winners and championship standings.

5. NOMINATION FEES: A fee of \$75 is required by June 1 for nomination, \$75 to sustain nomination by July 1 and \$100 by August 1 to complete entry. Late nominations will be accepted with submission of missed payments plus \$25 late fee (determined by postmark date) per missed payment until August 15.

6. All fees must be paid in US funds. No refunds in any event. Payment must accompany nomination. *Nominations are considered incomplete and late if not accompanied by copy of papers or vet's affidavit of age.*

7. There will be an office charge of \$50 per horse. \$200 per paid-up horse will be added to the purse. The division of the purse will be 25% to each go and 50% to the average.

8. Cowboy hat, long-sleeved shirt, western pants and boots are required attire for futurity entries.

9. DISTRIBUTION OF PAYOUT: 1–10 HORSES: 3 monies (50-30-20) · 11–20 HORSES: 4 monies (40-30-20-10) · 21–30 HORSES: 5 monies (30-25-20-15-10) · 31–60 HORSES: 6 monies (30-24-18-12-9-7) · 61 & OVER HORSES: 10 monies (24-19-16-13-8-6-5-4-3-2)

10. BBI SIDEPOTS: Futurity age (4–5 years of age) and Derby age (5–7 years of age) horses sired by Barrel Breeders Incentive stallions can qualify for bonus money in the BBI sidepots. Placings for the BBI Futurity and BBI Derby will be based on the average of two runs. Futurity times will be taken from the Barrel of Gold Futurity. Derby times will be taken from the Barrel of Gold BRN4D Open. The entry fee for the BBI sidepot is \$50 per horse. You can make that payment with your August payment or when you check in. See BBI literature or visit www.barrelbreederincentive.com.

11. Rider must be named by August 1. Rider may be changed between August 1 and start of futurity with payment of \$25 fee. No rider changes after start of futurity.
