The reason this was brought up or I make it now public, which was the case that created the thesis and book "Student Manifesto," is to show the attempts of creating patterns to later undermine me, possibly with things I don't know, because of who I aspire to be and am. As such and as stated in the Student Manifesto given with these letters to all governmental leaders at the school, is that "Fallen Angel" activities are at work. If in this embryonic stage and means little as just eroding an individual, then it means it was a role piece for gathered pattern materials for future undermining, which such false gathered patterns possibly went on after school and to this point. From these letters, it is clear that such undermining patterns was obviously purposely attempted, as in planting evidence, as if scripted in the individual (Goldberg); for instance, stating charges to me of a time when I was not there or even enrolled and such other loop holes in all the charges. Moles are key because they are inside, especially for long periods, hence trusted and can alter change or enact bureaucracy for the said regime they secretly belong to. In my case, put there to stop certain things I'm graced to do and progress in, to also "steal" that line for the regime he belongs to or work for. "Steal line" refers to [suckery](#), briefly mentioned in Part 1, Section 14 of the Student Manifesto; and also to smear my creditability and further keep me from knowing my true self with failures and depressive tactics, to remain a continued source of suckry (producing many lines) for that said regime. This is only a small portion of what was intended to smear my outlook as a Christian author; it was far greater and malevolent and probably not done, not that I can "far see" as these beings but as a saint we are gifted to "see in part" (1 Cor 13). Dear Mr. McQuick,

As we discussed in our meeting on May 26 last week, due to your continuing violations of BCC's Student Code of Conduct, specifically "False Representation," "Theft or Damage to Property," "Non-compliance with Directions," and "Disruption," and in consideration of your previous disciplinary probation, you are on Disciplinary Probation immediately for the remainder of your BCC enrollment. You may complete your classes this summer, per recommendation from Mr. McCawley, Program Manager for your BCC program, Graphic Design Technology. You are suspended from BCC for Fall 2004 and Winter 2005. Your Disciplinary Suspension will become part of your permanent academic record. Furthermore, if you continue to misappropriate representations of our College, or names or images of BCC staff in your brochures or websites, your suspension will be extended and BCC will consider litigation against you.

You were on Disciplinary Probation for Winter and Fall 2002 for False Representation, using BCC's name, the name of our Counselor, and "BCC-DTC Intersivity Christian Group" on a brochure and website you produced, which promoted your religious views. The website link, <http://www.geocities.com/freedomBCC/>, which is listed in your publication "BCC Evening Light" (copy to Mr. Cabello) continues to access your "BCC Downtown [sic] Center Christian Club" (copy to Mr. Cabello). Ms. Brinson and I asked you to remove all references to our College, but you did not comply.

Four weeks ago, Ms. Brinson asked you to remove another of your websites, with its references to BCC. You didn't. Two weeks ago I asked you the same, and as of our meeting, you didn't.

Shortly before our meeting, I received a Disciplinary Report about you from Mr. McCawley containing the following information.

In Aug. 2003 Mr. McCawley saw you installing software using our PC computer in the Mac lab, which is in violation of your Graphic Design class "student Conduct form," which you had signed at the beginning of the class! He told you that you could not use that PC again, but you used it again the next week.

In Nov. 2003 you stored more than 2 GB of backup work on our server. You were told the limit was 1 GB. You did not remove the data for 3 weeks, and Mr. McCawley had to do it himself.

Between Nov. 2003 to March 2004 you monopolized as many as 4 computers in Ms. Sobchack and Mr. McCawley's classes. You were asked to refrain but didn't. Mr. McCawley writes that during final exams, you took over 3 computers "and kept 2 students from getting to their computers . . . I witnessed 2 additional cases in [Ms. Sobchack's] classes, he was notified the classroom would be locked-up at 9:15pm; he stayed working till 9:30 and started burning CD's at this time, disregarding the order to leave."

Mr. McCawley writes that in April 2004, "Mr. McQuick used an exacto knife on the desktop of the classroom desks without any backing board underneath. The scars are still in the surface of the desks."

In March 2004 you used Mr. McCawley's name on a flyer seeking mothers to pose topless with their children for a photography assignment. Mr. McCawley writes, "I did not authorize this; in fact I discouraged the images, as they were not in keeping with the assignment." Mr. McCawley says that you published a newsletter called "The Portfolio," which included a photo of, and front page story about, him. Mr. McCawley writes, "Upon seeing it I asked that it be removed and reminded him that this was a clear copyright violation. . . . He did not remove it from the existing papers he handed out." Additionally, Mr. McCawley writes that at a graphic design club party at the end of the year, you prepared a questionnaire to get students "to come work for [you] doing free-lance jobs. . . . [You] brought the handouts and the company flyers complete with [Mr. McCawley's] name used as a sponsor to the meeting."


You and I discussed some of these issues. You said you couldn't connect with your internet provider and therefore couldn't remove your websites that used BCC's name and other BCC representations. Then you said you would remove the offending websites. You said, "I don't think he [Mr. McCawley] knows what he wrote. I think he's estimating." You said you didn't use the exacto knife on the desk. Then you said that you did use the exacto knife but sanded the desk. You said you didn't go to the graphic design club party, and then you said you didn't give out the handouts while you were at the party. You said you didn't use the computers that Mr. McCawley mentioned. Then you said you did use them after you were told you couldn't, but you used them because Mr. McCawley said you could use them. Your behavior demonstrates continuous violations of BCC's Student Code of Conduct, continuous lack of respect for its staff persons, and a disregard for the education which BCC has provided for you.

Episode 1

To whom it may concern

On July 6 I looked over a letter **dated June 2**, given to me by Mr. Goldberg, Student affairs Director, concerning disciplinary actions; the letter is enclosed. In my estimation the letter was probably given to me two or three weeks ago, prior to July 6. The time to read it was non-existent as I was doing five classes and 3 were nearing the end, thus finals. In fact, each morning for that semester I woke up 4:30 a.m. to catch the 5:30 a.m. bus for classes at 9:00 a.m. Then sometimes I have an evening class that is schedule to finish at 9:00 p.m. By bus commute, I then arrive home at 11:00 p.m. each night to get up at 4:30 a.m. to spend the entire day at school; most often without food. So the optional appeal within five days of the letter was not possible on both our parts. Therefore, I've decided to appeal Mr. Goldberg's decisions to the board, staff and President.

Not only are most of the charges fallacious, but also, the entire ordeal seems ridiculous. No disrespect or disdain intended at anyone, for I value the servitude of our educators. Moreover, this wants to seem as if it is a misunderstanding or lack of communication and knowledge. I'm not seeking trial or even group mediation at this point, for in such a case, in Mr. Goldberg's own words, "who would they believe?" He being the lauded Student Affairs Director with four masters' degree and accredited companions, against a student who hasn't even finish his associate degree at BCC and travels the bus with a big bag. Basically, students have little voice. I prefer to accept his decision and seek another college than consume more time on any forms of trial or mediation. I simply want to finish my degree and preferable graduate this fall; or spring. Reason being, I sacrificed a great deal, especially these last two semesters, to finally finish my A.S degree and finally move on; Doing more than 14 credits these last two semesters in a hope to be done. In addition, waking early, staying up late - sometimes up till 2:00 am if I have a test the next day (still getting up a 4:30 a.m.), spending extra lab time to finish assignments and polish my portfolio, commuting by bus - even between classes from campus to campus and many more things. Then at the end of all this travail, all these allegations are brought up to prevent me from doing classes and graduating this fall. Though most things are coincidental, we can't help but think some are "planned." For instance, notice a few of the clusters of charges taken against me:

a) "In August 2003 Mr. McCawley saw you installing software..."

- I wasn't even in any graphics class August 2003, or at the downtown center. I was on 40 days fasting then and had only one class at the Central Campus, which despite the fast, I had to attend. Away from that class I was at home in spiritual exploits.

b) "In November 2003 you stored more than 2GB of backup work on our server..."

-I wasn't even enrolled in classes that semester, because my financial aid did not come through. I took the time to stay home, do research (research/reading of nearly 200 documents/books), write and finish other obligations.

c) "In March 2004 you used Mr. McCawley's name on a flyer seeking mothers to pose topless with their children for a photography assignment. Mr. McCawley writes, 'I did not authorize this; in fact I discourage the images, as they were not keeping with the assignment.'"

-This is where it gets ridiculous. Before the assignment I asked Mr. McCawley about my intended assignment and he approved; in fact, the approval wasn't even needed, because the assignment was to photograph a series of anything, anyhow. But I just thought it was common courtesy, which more than likely no one else did. Not only was he delighted at the project but authorize me to use the photo studio. In fact, when each mother and child came, he was the one who opened the studio and greeted the mothers and I introduced him as my Teacher. His name is not on the flyer, I have enclosed a copy, which was also on the first floor wall of the downtown center; authorize by Trish. If his name was on the flyer he wouldn't have taken it from me and placed it on the 5th floor message board for advertisement, as I asked of him. Plus, he gave constructive comments on them when they were presented in class. You then see how ridiculous the charges appear and why I'm at utter confusion to where these things are really coming from.

d) Again take this exertion, "Mr. McCawley says that you published a newsletter called 'The Portfolio,' which included a photo of, and front page story about, him. Mr. McCawley writes, 'Upon seeing it I asked that it be removed and reminded him that this was clear copyright violation....' Additionally, Mr. McCawley writes that at the graphic design club party at the end of the year, you prepared a questionnaire to get students 'to come work for [you] doing free-lance jobs...[Mr. McCawley's] name used as a sponsor to the meeting.'"

-"The Portfolio" (newsletter) was apart of the class assignment and the graphic design party. When I came to him about the portfolio class, he told me I had to have a "leave behind" for this class; that is, a separate piece from my portfolio case, as a leave behind for Employers/clients. He said it has to have my works. Suddenly I thought to just give him a CD-R with all my works on it and probably design the cover. With further dialogue he said that it has to be something the Employer/clients can handle and look at your works. Given the time constrains, the only thing that could be done was a newsletter. I asked him about the idea; he said that it was okay, as long at it showed the works I have done. He did not mention anything about a possible copyright infringement, but being flattered, shrugged at the idea of a write up. In fact, when the class was over and I handed him my portfolio, resume and the 'leave behind,' he was impressed and even mentioned that I did more than what he thought I could. I just thank God the class was over. His write up was to show appreciation and give an impression in this CLASS Project for him only to see. This is not the only class that a picture of a teacher was used in a class project, especially to impress and they becoming "flattered". Then I was told of the graphic design party. I thought not to go because I was weary of work and my family was going out of the country. It was then recommended that those in the portfolio class should attend and show their work - Portfolio Case and Leave Behind - whereby a desk would be provided. That made it worst I didn't want to attend - more work. Then it was announced that those in the Portfolio class must attend. Not only would I have to prepare my Portfolio and "leave behind" for a graphic design party, but also cut in my rest time before the next excruciating semester. Every Portfolio student at the party had some sort of "leave behind", to which they duplicated and gave out. My leave behind was the class project newsletter, "The Portfolio," of my achievements at BCC. Mr. McCawley did not prohibit this either, as he shuffled them correctly for me on the desk. The idea of "The Portfolio" newsletter was just a quick fix for a class project, but attendees at the party thought it was such a great and unique idea that I planned to do one for 2005 when school is finished and I'm settled; I've included a copy. The next time I came to school after the party, Rick called me in the class and gave me three of the "The Portfolio" class project newsletter that were left behind that night. I thought what to do with them, throw them out or.... So I gave one to Mrs. Carol Brinson, whom I'm friends with and Mr. Goldberg who I thought always had my best interest at hand. In addition to this, I could not have then said to Mr. Goldberg that I didn't go the graphic design party, as he alleges, as it was mandatory. And I didn't give out any questionnaire or flyer at the party, being intimidated. Rick himself, in the manner he always spoke, said I shouldn't, but if "you want to give it out on the side that's okay." I did neither, being afraid to do so. That's the 'rapour' Mr. McCawley and I had. Plus Mr. McCawley name was not on any flyer endorsing or sponsoring anything. Any reference I have of him would be that he taught me. It's that true. You can't stop someone from saying they were taught by thus and thus. It's like saying I can't say I have on a Reebok shirt, when I have on one. Or, I didn't go to BCC when I went to BCC.

e) "Between November of 2003 to March 2004 you monopolized as many as 4 computers Ms Sobchak and Mr. McCawley class..."

-Not only was I not in class November 2003 because of financial aid problems, but also it is impossible for someone to monopolize 4 computers, two likely and three the most. And most students have occupied two computers one time or the other. When going to the Mac lab on the fifth floor I have to always ask the person if they are also using the computer next to them; sometimes they have it turned to them. For this program it always happens. Any graphic designer has at least two computers on his desk.

These and other incidents are fallacious, trumped up and confusing. And from the above you can clearly see that something is wrong, like taking a class when I wasn't even registered at BCC. I'm not saying incidents haven't happened, that would be impossible for a zealous student and a good portfolio driven program. But all can be put in context, dissipated and none warranting suspension. Especially when I "practically" only have one class left. That's the reason the charges numerous clustered, so as to prevent dissipation of all. That would be extremely time consuming and this letter is already long – touching only a few errors.

The agenda of Mr. Goldberg is not clear to me but his accusations, given his position, are weighty and stand in the way of what would be my first ¹graduation "ceremony" since kindergarten (basic school). I'm not sure, but in the first sentence of the letter Mr. Goldberg sent, the phrases in quotation are from the BCC policies he has and more than likely refers to the following:

"FALSE REPRESENTATION": refers to the draft of items given to Mrs. Brinson. None of the things given to Mrs. Brinson was official and no one saw them except her. They were drafts of suggested ideas; in other words, only can be made official by her approval. A procedure I also went through with the staff advisor at the North Campus. The only thing that was new to me and worth any mention was the "BCC Evening Light." As a zealous Christian and freshman, I decided to make a one time print out for the Sept 11, 2001 incident. He explained to me that I couldn't give these to the teachers in this manner. I did not know, so I guess I was at fault. Therefore, he called me in trial as a freshman for this incident, which I did not contest because I was new, and he seems to know what he was doing. So I just accepted his probation that year. At the time, the link <http://www.geocities.com/freedomBCC> had no literature on it and no content as I didn't have the time to laze-on with Mrs. Brinson to put anything up. It only had the flash intro. It was only used last semester (spring 2004) to show the draft of a potential downtown Center Christian site I made for my portfolio; which I had changed to <http://www.geocities.com/dtcbcc> because I had problems logging on. She asked changes I made them. She asked changes again but I couldn't attend to at the moment but later did, with the creation of a new third geocities account; because I couldn't log into that one for some reason. This was in the background for they only had a redirect URL; printed on the sheet given. After that we spoke and Mr. Goldberg came in as well and they requested deletion, one reason she suggested was that it was not feasible since the club is not currently operational, "it needs members." He kept interrupting with his reasons of false representation. I said okay, but couldn't attend to it with my hectic schedule and 'lack of sleep' cycle. When I did get to it, I couldn't access the site to do what I wanted. This is the same thing that happened with the previous geocities account. Nonetheless, I kept trying to no avail, until Mr. Goldberg called me in his office about it. He opened his email and showed me the link and said it was still up. I told him the situation, but he just refuse to believe. However, I notice that the link he had was not the site itself, but in the letter given to Mrs. Brinson, which he took, was the redirect address I used to present the draft site - www.dtc.andmuchmore.com. A redirect URL is not a Website but redirects to the Website or any Website. So I changed the redirect, which I could log into elsewhere at alias.com. It had pointed to the third geocities account where the draft was. A little Internet savvy language, which if you don't know result in things like Mr. Goldberg calling me a "Liar." However, I overcame all this bureaucracy and contacted the North campus and the head of the club, campus-wide; still having this site in my portfolio showcase. I mentioned my intent for the club and shortly gave her a draft of the site, campus-wide, which included dtc. After she received my email with the link to the draft, we sat down over it mainly on CD-ROM. She was elated and pre-approved it, awaiting mainly contact info changes and laze-on with her other faculty advisors. She even showed it to

¹ My high school Vice President, seeing me after the graduation, asked how comes she didn't see at the graduation ceremony. I told her I wasn't on the list. She exclaimed. I thought that was a joke seeing she's the person in charge of graduation. But I later come to realize that what I'm trying to prevent here, occurred. I just accepted that my name was not on the list and didn't let my voice be heard; not knowing it could be a mistake. Why? Graduation meant nothing, as long as you passed the Regional exams. In fact, when looking for job, that's the only thing that counts and the only thing accepted as a High School Diploma in local colleges (including BCC). Nevertheless, I was the first to be allowed in the 2 year Cambridge University Program (sixth form); as told by my Vice principals acquaintance. The only thing that was good from this was that I got a little "lee-way" in undertaking several responsibilities and even offered presidency of the student Council; but denied because I was already a president of a club and captain of the basketball team. Before this letter, I just allowed everything in my life to just slip.

another in my presence and she thought it was okay too: Whereby the site should be up soon on another server, if all goes well.

Therefore, the charges of false representation are fallacious. I did not presume to represent BCC in anyway; even if arbitrarily away from this incident, only as a student, which I am. For instance, a graphic industry class trip. The site made in 2004 was a draft to Mrs. Brinson and was seen by no one else; I had plans to publicize it on a poster and even started it, but waited approval of the site. How could it be a representation when it was not "publicized" and simply a draft? How could it be a workable draft if not uploaded to an internet server for trial, as taught in my web publishing class? How could it be representation when "Oneil McQuick" didn't carry out indenture in the name of the school? The site stayed between me and Mrs. Brinson, then Mr. Goldberg and whom he may have laze-on with concerning this incident. Therefore, I denounce these allegations of false representations (Isa. 54:17).

"THEFT OR DAMAGE TO PROPERTY": This probably refers to the exacto knife incident that I did not deny; which happened all that day. I realized the serious erosions in the next class and rectified so that others might not be affected. I was hurrying to make a presentation for a class and cutting the paper to fit on the matt board. In fact, I was the only student presenting. That is, even with all my constraints I still found the time to work above average and present before anyone else. I had no idea lightly cutting the paper would cause such erosions, I guess in my quick preparation it happened. I rectified as soon as possible with sand paper, also with Mr. McCawley altering me. The sand paper work well to the point that the lines weren't visible; so in a class setting, where this desk was, no one would be affected. This is one of those incidents that were the result of a productive program. Damage to property can only be categories in a **deliberate** attempt to damage property; like taking revenge on the school by setting fire to a lab, or slashing the tires of the school's commute. When he called me in his office and said he would be finished with the letter by the end of the next day, I was still too beat to have any emotions, much more to take great notice that he mentioned theft. I would have said to him right there and then that there was nothing stolen by me at BCC. It's probably words bundled together under the school's bylaws - "Theft or Damage to Property."

"NON-COMPLIANCE WITH DIRECTIONS": This is an adult school not high school or kindergarten. Any non-compliance with an academic request is either a miscommunication or an unavoidable result of a productive program. For instance, several of us nearing the end of the semester (winter 2004), often went over the storage limit of 1 GB; none, including myself, went over 2 GB. We willingly did not defy the rules, but simply working and storing. Every now and then it is exceeded. When we see it, we reduce it; like taking out the garbage. And the cycle goes on: I more than anyone else, because I was doing more classes than anyone else. This is simply the result of a productive program. Thank God there are problems like these, it means students are working and improving the quality of students BCC outputs.

"DISRUPTIONS": The same thing goes for disruption. The computers are networked and students are allowed in and out of the lab. People walk in and out whether a test is going on or not. In fact, in one of my classes shortly before I was handed my test paper, a student was at my seat when I got up and even shut down my computer when I still had things on it. I thought, "OKAYYY!" But realized that like everyone, the computers are shared, with shared storage and we strive to be a cohesive group. It didn't disrupt my test or score, which I got an "A" in that class. These are simply the result of a very good productive program. Take a walk on the fifth floor, building 33, downtown, and look on the wall of fame, such dynamic real world graphics cannot come from a program with any less caliber. Nothing good is done in comfort; especially with explosive creative individual as graphic students.

As can be seen from this letter, the charges are simply clustered together to prevent me from finishing classes. The allegations brought against me are simply fallacious, some ridiculous and don't even make sense. And thus, my accusers and companions can endlessly add more². Not only is a suspension for the next semester but even the following; preventing me from graduating either in December or May. He even

told me that the suspension would be for the fall only, but now it's for both terms. All this when I only have one class to "practically" do: Which is not even a class, per say, but simply internship - I working away from the school's classroom in a job environment. I can't help but to smell deliberation. This also happening when my financial aid might be coming to an end. Please, by all means, let "good sense" and the prestigious standards of opportunity that BCC prides itself on³prevail.

In addition, I had thought to write to the board on many occasions but saw myself not fit and even what I may say might be of no importance or an affront. And with that I didn't want to stigmatize myself, especially when I wanted to graduate. However, this seems like the coincidental plat-form to voice my opinions; not dogma or complaints, simply opinions and suggestions concerning what I've seen. Hoping that it might help to improve a prestigious organization I love. If you know me, you know I love to give info and suggestions, and with that I hope the "**Student Manifesto**" is welcomed. It is in a separate folder provided, with the said name given and/or on a CD-ROM.

I do hope my letter has aroused you to help me finish my education at BCC this fall, and remove from my record the stain of this suspension. With the enclosed "Portfolio" of my work, you'll see that I'm a promising student that has and will make BCC proud; the photograph of me was taken by another student while in the photography class and studio. Much thanks and accolades to you also, for your servitude to such a cause. And, thanks in advance, for allowing a "destitute" student to realize his dreams.

RESOLUTION AFTER ACCUSATIONAL CHARGES IN EPISODE 1

The Committee formed to oversee the matter was prudent and honorable to allow me to finish my class and graduate that Semester, even though Mr. Goldberg wanted to have me suspended for two Semesters (fall and winter), pushing my last class to take and graduation a year later, or as often intended, give up. One of the few times I've stood up to continued "wasting" by the persons mentioned in Response letter 2 at the end which the asterisk denotes. However, to appease Mr. Goldberg, the following was implemented for the two resolved "suspend" semesters:

The Discipline Committee of Academic Standards has heard your case and has recommended the following:

Dear Mr. McQuick,

As a result of your many violations of the BCC Student Code of Conduct, summarized below, and your Academic Standards hearing, which you didn't attend, Vice President Cabello wrote to you on 8/20/04 saying:

"You may complete an off-campus internship to meet your degree requirements.

You are not permitted to use any computer at any BCC location, including the library.

You may not participate in any college extracurricular activities.

If you wish to come on campus to conduct college business, you must obtain prior approval from Maier Goldberg. . . ."

You were allowed to finish an off-campus Internship to complete your Graphics Tech. degree, which was awarded. But subsequently you came to BCC at least several times without my approval, quickly leaving twice when you saw me. Recently you've used our LRC, changed your major to Multimedia Tech, and registered in the current term for 4 classes: 1 at Central, 2 at North, and 1 at WHC.

You violated the terms of your BCC enrollment, given to you by Vice President Cabello. You are hereby notified that you are on probation for a full year: Summer Term 2005 to Summer Term 2006. Furthermore, you may not use any computers at WHC. Other BCC officers may impose additional Loss of Privileges (Student Code of Conduct, Sanctions #3) and/or other sanctions. You may appeal this decision per guidelines that appear below your summary of violations.

Summary of violations:

In our previous meetings and my letters to you, I've told you of your violations of BCC's Student Code of Conduct, specifically "False Representation," "Theft or Damage to Property," "Non-compliance with Directions," and "Disruption." Additionally, Ms. Brinson and I asked you to remove references to BCC from your religiously-oriented personal websites, but you did not. We asked you again, and again you didn't comply.

This refers to page 3 of the first response letter in Episode 1; of the drafted/proposed BCC Christian Club website, like what other clubs have.

By reference he allegedly means indenture (or representation in the name of the school).

McQuick, p.2

The Program Manager of your program, in which you graduated, wrote that he saw you violating the Graphic Design "student conduct form," which you signed, by installing software using a BCC computer. Although he reprimanded you, you did it again the following week. A few months later, you again violated the form by storing twice as much work on BCC's servers than you were allotted, and you didn't remove the data as Mr. McCawley requested. He had to do it himself 3 weeks later.


Mr. McCawley says you monopolized 4 computers in Ms. Sobchack and Mr. McCawley's classes and disregarded Ms. Sobchack's order to vacate a room at a 9:15 p.m. closing. Mr. McCawley writes that you "used an exacto knife on the desktop of the classroom desks without any backing board underneath [scarring] the surface of the desks."

Mr. McCawley says that you published a newsletter called "The Portfolio," which included a photo of, and front page story about, him. He writes that he asked you to remove them and you didn't. He writes that at a graphic design club party at the end of the year, you prepared a questionnaire to get students "to come work for [you] doing free-lance jobs. . . . [You] brought the handouts and the company flyers complete with [Mr. McCawley's] name used as a sponsor to the meeting."

In our discussions and per physical evidence, you admitted to most of these items (see my letter to you of 6/2/04 outlining your statements), and you've said Mr. McCawley approved some of your actions described above, which he denied.

You have a right to appeal my decision to the Vice President of Student Affairs, Mr. Robert Cabello. Your written appeal must be within 5 days of receipt of this letter.
