Shipping Addendum

Buyer, _____, requests that Piece of Eden Pomeranians (POE) ship his / her newly purchased dog/puppy to them via airline transport. Buyer understands they are responsible for all fees associated with shipping; including but not limited to airline fees, crate and health certificate. Buyer agrees to hold POE and Cynthia Lowe harmless for all causes related to the shipping of this dog/puppy; including hypothermia, hypoglycemia and contagions.

Buyer has read and initialed below terms of shipping and has had an opportunity to refuse such terms prior to purchasing a dog or puppy from POE.

_____ Buyer understands and agrees that their dog/puppy will not be shipped in temperatures below 45 degrees nor over 80 degrees. Should Buyer purchase a dog/puppy during a time of year in which shipping does not meet the above criteria, he/she agrees to wait until shipping is possible. Buyer may drive or fly into Michigan to pick up their puppy.

_____ Although POE will arrange shipping, smaller airports can be difficult to ship to. With the exception of overseas shipping, POE uses only two airports, Flint, MI and Saginaw, MI's MBS Airport. **NorthWest, ComAir/Delta, and AirTran** are the airlines available at these locations. Buyer's would like their dog/puppy shipped to _____ (City). **City must be serviced by one of the airlines mentioned. It is the Buyer's responsibility to confirm that shipping into the city of their choice is possible. You Must Call the airline!! Online passenger information does not mean it is possible to ship an animal into any particular airport.**

_____ Buyer requests that POE purchase shipping insurance for the transport of this dog/ puppy; either by means of Declared Value (approximately .50 to \$1.75/ \$100), or Private Carrier insurance (approximately \$3.75/\$100). Buyer understands they are responsible for this fee.

Buyer elects: Declared Value Private Carrier Ins. Neither, no insurance. (**Initial one**)

_____ Buyer understands that if shipping cannot be arranged to their preferred airport/city, their dog/ puppy will be shipped to the next closest airport that services one of the above mentioned airlines.

_____ Should Buyer, for any reason, be unable or unwilling to accept their dog/puppy upon arrival at the airport, the Buyer agrees that POE will resell their dog/puppy at its current value, which may or may not be the purchase price, to a new buyer approved by POE. Buyer will be refunded the resell price of the dog/puppy minus their deposit and any other expenses incurred by POE related to its resale; which may include advertising, boarding and any veterinary care that may arise. Additionally, Buyer understands their deposit will be forfeited and will not be transferable to a future dog/puppy purchase.

_____ Should Buyer wish to arrange their own method of transportation other than airline shipping, Buyer understands that POE has the right to refuse any transportation arrangement that is deemed unsafe for the dog/puppy; or inconsistent with the above terms.

Buyer agrees to ALL of the above terms and understands this is a binding contract as part of their sales contract with POE. By signing below I am indicating that I have read and agree to the above terms in their entirety.
