## PARTICIPATION

All **PFMC Youth Track** participants must be present at all scheduled events during the **PFMC Youth Track** and at appropriate places following events until picked up by parents, adult sponsors, or chaperones identified by a **PFMC** event nametag.

No **PFMC Youth Track** participants will be permitted to leave the **CLARION HOTEL** property at any time, unless accompanied by a parent, an adult sponsor or chaperone identified by a **PFMC** event nametag.

Adults taking **PFMC Youth Track** participants off-site accept full responsibility for those **PFMC Youth Track** participants.

## DRESS CODE

All **PFMC Youth Track** participants are expected to dress in a fashion that represents modesty and good taste. Clothing must cover all undergarments and midriffs. Bikini tops, low cut tops, short shorts, or other inappropriate attire are not to be worn at anytime during the **PFMC Youth Track**. Clothing with vulgar or offensive language or obscene pictures is also not appropriate.

The **PFMC Youth Track** Leader and **PFMC Youth Track** participants are asked to address the dress code of the **PFMC Youth Track** in introductory remarks.

## SMOKING POLICY

All public event areas within the **CLARION HOTEL** are hereby designated smoke-free facilities.

During the **PFMC Youth Track**, we ask that all participants, including adults, refrain from smoking (unless outside the buildings or in their own private sleeping accommodations).

## ENTERTAINMENT EQUIPMENT

No electronic entertainment equipment, i.e. portable television (TV), radios, compact disc (CD) or tape players ("Walkman"), or video games are allowed in the possession of **PFMC Youth Track** participants while in **PFMC Youth Track** event areas. Leave them in the private vehicle you arrived in or in private rooms in the **CLARION HOTEL**.

## MESSAGES

Cell phones are to be turned off during the **PFMC Youth Track** sessions and may only be used during breaks and other free time. If someone from home needs to contact a **PFMC Youth Track** participant without a cell phone where a message can be left even with the phone turned off, they may call the **CLARION HOTEL** at (856) **428-2300** and leave a message in the parent, adult sponsor, or chaperone's room message system.
