Abstract

A questionnaire survey was conducted to evaluate the need and the proficiency of site technicians in enforcing safety in the Construction Industry in Hong Kong. The results indicated that there is an increasing involvement of safety roles undertaken by site technicians and there is a need to provide more training to them. A training curriculum in construction safety was developed such that a prescribed standard of training should be provided for construction site technicians.
