ELIGIBILITY TERMS AND CONDITIONS

1. Who is eligible for a NPWS exemption?

All RFS active volunteers are eligible for one (1) complimentary 1-year "All Parks" Annual Pass for a nominated vehicle registered at the officer's home address for each year they are an active volunteer.

2. What does the Annual Pass entitle me to?

The NPWS "All Parks" Annual Pass entitles the volunteer's nominated vehicle to free access to all NPWS managed national parks and reserves.

Please note that the Annual Pass is linked to the nominated vehicle's registration number and is not transferable between vehicles (see the Annual Pass carrier for all terms and conditions).

The Annual Pass does not provide free or discounted access to other NPWS activities such as Discovery programs, camping, tours, museum entry or entry to the Cape Byron Lighthouse carpark or Stockton Bight.

3. How do I get my Annual Pass?

Application forms and Annual Passes will be available through your local D/T/Z office and will be issued locally.

Once the D/T/Z Manager has approved the application form and the correct documentation has been provided a complimentary "All Parks" Pass can be issued. The eligible volunteer must sign the application form when they receive the pass.

4. How do I get more Annual Passes?

Additional Annual Passes can be purchased through your local DECC Annual Pass sales outlet, the DECC Annual Pass Centre or the NPWS Internet site.

5. How do I replace my Annual Pass?

You can only replace your annual pass if the pass has expired, you have sold your vehicle, your windscreen is replaced or your vehicle has been written-off.

You must retain your original Annual Pass and contact the DECC Annual Pass Centre on 9585 6068 for further information on what documents you must provide. An administration fee applies.
