**Bred by Exhibitor (BBE) Class eligibility (revised 09/02)**

- All dogs entered in the Bred by Exhibitor Class must be individually registered with the AKC.
- The person handling the dog must be a breeder of record of the dog and an owner of record of the dog.
- To exhibit in this class family members must be a breeder and owner of record.

### Junior Showmanship Competition

AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club - PHONE: (919) 816-3776.

- **Novice Junior Class:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **Novice Intermediate Class:** Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **Novice Senior Class:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **Open Junior Class:** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **Open Intermediate Class:** Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.
- **Open Senior Class:** For Boys and Girls who are at least 15 years and under 18 years old on the day of the Show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

## **Notice to Exhibitors**

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or Judge, or barred from the competition by action of Event Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the match, no refund of entry fee will be made. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further Judging will be excused.

Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in judging ring when their classes are called to be judged. All dogs present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

Exhibitors must be governed by any rules or regulations of civil authorities and/or local restrictions. An Administrative Fee of \$2.00 will be withheld from all refunds for entries cancelled prior to the closing of entries.

The Puerto Rico Labrador Retriever Club, Inc. does not assume any responsibility for contents left in vehicles. The Match giving Club, the Match Secretary, their agent, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.

Do not leave dogs unattended in rooms or cars. You are responsible for any damage you or your dogs do. Please clean up after exercising your dogs. You may want to come back next year. Puppies or dogs not entered will not be allowed on premises. No exception. No Admission Fee. Portions of the proceeds will benefit local charities. No grooming tables allowed in ring area. No gasoline or diesel generators are permitted within 100 feet of any tent in which this dog match is conducted. No practicing allowed in rings at any time.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. In an emergency situation, an exhibitor does have the option of withdrawing their entry and receiving a refund.

## **Directions to Hacienda Sabanera Match Site**

Road 173 Km 3.0, Ceiba district, Cidra, PR

- **From the north:** Take PR # 52 Luis A. Ferré Expressway to Caguas. Take Exit #18 and turn right on the intersection, Road 196 West to Aguas Buenas. At the end of the road you'll find a traffic light in front of Jardín Botánico. Make a right turn taking Road 156 West. This road will become a rural road and take you across the town of Aguas Buenas. Make sure you stay on Road 156 West across the town. When you come across "Anisa Printing House" make a left turn and take Road 173 South. On Km 3.1 you will find the intersection with Road 783. Make a left turn going around "Brisas Del Lago Bar". Hacienda Sabanera will be down hill to your right, follow the signs.

- **From the south:** Take PR # 52 Luis A. Ferré Expressway to Cayey. Take Exit #32 to Guavate/Cidra/Cayey then make a left turn under the bridge. At the traffic light make a left turn to Road #1 West. Make a right turn on the intersection with Road 735 West. Make a right turn on the intersection with the Road 734 North. At the traffic light on the intersection with Road 7733 make a right turns to Caguas. At the traffic light on the intersection with Road 172 West make a left turn. Turn right at McDonald's. On the next intersection makes a left turn (Factories). At the end of the road turn right and you'll see Don José's Restaurant. At the intersection with the Road 173 North make a right turn and follow the signs to Hacienda Sabanera.
