After the monthly meeting with (UNOCHI) in 14-01-2002 the representative of Zhinan-WUK pointed at the badness of the soap in SCR 986 on people skin. In 21-01-2002 the representative required

from the Scientific Advisory Bureau in Univ. Sul. to ask after or making analyses about the soap that distributes on people. Gratefully, Sul.Univ. did the analyses then discovered:

- 1.It consists of liniment dripping.
- 2.It consists of (Pigment) which is indissoluble.
- 3.It has (corrosive) that leads to skin itch .

Wherefore, WUK Health Dept. wrote the letter no.129 in 26-3-2002, with the analyses attachment to UNOCHI for curing and observing this case in order not to more damage and provide a healthy life for Kurdish people.
