Subject: Request for a criminal investigation for hate crime

I'm a physically disabled woman, age 53. I now have to use a wheelchair, and in addition to my spinal injuries that created my disability, they now believe that I have MS. I've been the victim of a hate crime ever since I attempted to sue Microsoft for sexual harassment. I've attempted to get this investigated in the past and even have letters from the White House. But all that ever happened was that it was passed around, eventually ending up with the EEOC in 1994.

Instead of investigating my case, the EEOC made up a false story that I had broken into the Federal Building in Seattle. They claimed I had force open a sliding glass door. Then I made my way upstairs and broken into the office.

The case was investigated by Mike Wally of GSA Security. It was eventually dismissed. I asked him if they knew who I was? The women who filed the sexual harassment complaint against Microsoft. He said yes. I said, "they made this up." He said yes. They he told me that the door was broken and not closing all the way and had been fixed the day after I left a letter there.

This is Malicious Prosecution. These are federal employees! Yet NOTHING WAS DONE. And the harassment has never ended. Nor has the continuation of me being denied my civil rights.

There was no investigation of the retaliation by these people associated with Microsoft. Most of the harassment or other problems seem to be from either vendors or contractor for Microsoft. Right now I'm having a real problem with various services through Access.

I knew someone in the state was flagging my social security number. I'm an engineer and this is pretty easy to do. I've had someone cancel my pick up for rides, leaving me stranded for hour in the dark waiting for a ride, etc. This is extremely dangerous. At this point I'm using metro, but I had to file a complaint with them also. The bus drivers were refusing to pick me up. Then one told he was told NOT to pick me up.

My case manager with Seattle King co. Aging and Disabilities Services--COPES--told me on one occasion that they didn't want me leaving my apartment. They were forcing me to have people come into my apartment for more hours than there were work, just to do surveillance. At this point I don't really have services from them. If it weren't for Meals on Wheel, I would have died.

These people seem to think they are promoting themselves with the Gates Family. I know that is why Governor Gary Locke refuse to do any investigation. I've been harassed viciously. In 1999, Microsoft got an ex parte order allowing them to demand all my e-mail communication from my service provider. So this is no small matter. They have a lifetime anti-harassment order against me prohibiting me from attempting to contact anyone in the company about this.

This is a hate crime. And I've come very close to dying in my apartment. In April, I fell in my apartment. I attempted to break my fall and my elbow bent backwards and dislocated, breaking the bone. I also sprain

my ankle. I was eventually able to get to my phone and called 911. I was taken to Valley Medical, where my condition was diagnosed in the ER and placed in the hospital so I could see a specialist to determine the extent of the damage for potential surgery. This never happened. COPES intervened and I was discharged from the hospital in the morning without seeing a specialist against my protest. I told them I was all alone.

For 4 days I was abandoned in my home at serious risk. I couldn't even toilet myself properly or open a can of soup. This was done intentionally to me.

I can go on with this... It's been an endless ordeal. On one occasion I had 3 Microsoft engineers, messing with a psychotic that lived next to me in my HUD apartment complex. They were telling him I was spying on him through his computer. I eventually found out about them when I met one who came to pick Jay Jordan up to take him out. He didn't know who I was because I look so haggard these days. So he began talking to me outside the apartment and was bragging about being an engineer in the C Language group at Microsoft.

I don't think anyone can really understand what it's like to be the focus of this kind of retaliation. They go after every thing in my life. The police will do nothing. This is NOT civil issue when an agency like COPES can prevent me from getting a cast put on a broken arm. This is not a civil issue when someone working for Laidlaw can prevent me from getting to a doctor in Seattle for MS. This is a hate crime. This is Malicious Harassment and it's intended to cause me both physical and emotional trauma.

Find enclosed some documents. I've included the documents I've just submitted in my Administrative Hearing. I have asked them to support me in the need for a criminal investigation of COPES because I thought I was going to die when they abandoned me in my home in such an injured state. I should have been in a nursing home.

I'm also including a legal document. It's the one Microsoft used to get my e-mail from Transport in Oregon. These people had no right to know who I was communicating with. And they had no right to harass or threaten anyone that was befriending me.

The security contractor and an attorney at Preston Gates and Ellis seem to be doing this kind of thing. I've had major problems with them since I was injured on the job at Microsoft due to an assault by another Microsoft contractor on a business trip. The law firm never even did a deposition in that case and it's been a really bad PR issue for Microsoft having a women left disabled due to sexual harassment in this community. They don't want me contacting either the Gates family or any other executives about this. I did any way. This is why so many of them are selling there stock, even though Microsoft's business is doing so well. I think that is insider trading. If your interested in that one, you can verify it here:

I've monitored the insider trading since it's been on the Internet. In 1998 I came under attack by Microsoft. They found out I was attempting to send e-mail to Bill Gates about my problems. So I contacted a few members of the Board of Directors about this harassment. And they started selling.... But after I caught them spying on my e-mail, I contacted them again. Paul Allen eventually resigned from the board and Gates as CEO in January of 2000. In 1999, Gates' was selling more than \$1 billion in Microsoft stock a month. I don't know why Martha Stewart is going to court over \$45,000 in stock sales when you have this going on at Microsoft.

I have to find a way to deal with this. I need medical treatment for my condition. I need social services to stay alive. So this retaliation and harassment is going to kill me. But it's taken of the feeling of being tortured to death. Please order a criminal investigation of this situation. We can start with the SPAM that was sent to me by a state computer this month. You have an explanation of that in my Hearing's papers. I would also like to point out, that most government computers and even corporate computers are managed by contracting agencies that have many contracts. So Laidlaw is working for both Seattle and

Microsoft. And if someone has this kind of access, it's a simple thing to flag someone's social security number. Mine is attached to all my medical and government services, including my transportation with Access. To make matters even worse, many of the contractors are in foreign countries. I was really shocked with I was SPAMMED by a state computer and then noticed looking at the routing information in the header that the SPAM was coming from a computer 8 hours ahead of our time. This might be in China or Malaysia where we are out sourcing much of our own government's work now.

If I were a racial minority or a Jew, the malicious harassment would be investigated years ago. But because I'm a woman and disabled nothing was done. Well, when I first attempt to get this investigated I only considered myself handicapped. Now every time I attempt to bath myself I'm at risk of falling and injuring myself. I had a very bad fall last March and laid on the floor of my bathroom unable to move for more than a half hour, before I was even able to drag myself down the hall to my room and crawl into bed. This kind of thing shouldn't be happening to anyone.

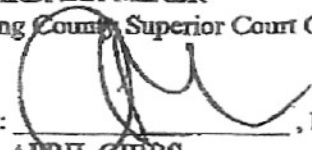

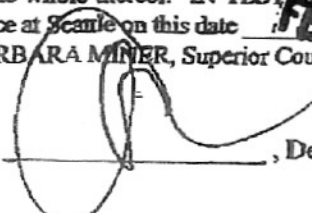
