Prospective Member hereby agrees to indemnify, defend and hold harmless RMRA from and against any and all claims, suits, proceedings or causes of action of any kind arising out of or during the course of Prospective Members' use of RMRA's facilities or grounds. Prospective Member hereby agrees to periodically execute a release from liability in favor of the Association.
5. RMRA hereby reserves the right to reject any Membership Subscription Agreement with or without cause.
6. This Membership Subscription Agreement contains the entire agreement among the parties. All prior or contemporaneous oral agreements are hereby null and void. In the event that any dispute arises, the governing law shall be Virginia and all disputes shall be litigated in the general district and/or circuit courts of York County, Virginia.
