Implementation Status and Key Decisions

The second supervision mission was held from June19-22, 2018. The project is on track and implementing activities on schedule. The Higher Education Department (HED) has signed the MOUs with the 70 selected colleges. The MoUs with the six selected state universities are expected to be signed by the end of July 2018. Three of the four first year DLIs have been met and the Bank has disbursed the allocated amount for them. Given that there is good progress on the project activities the ratings for the PDO and the IP are satisfactory.


