**Important**

- Time table of several trains are being updated from 1st December 2006, Please check exact train starting time from boarding station before embarking on your journey.
- The accommodation booked under this ticket is not transferable.
- This slip is valid only for the seat/berth/coach number specified herein
- This slip is to be carried by the passenger during the journey along with the above photo identity card and is valid only when presented with this photoID. If the relevant photo ID is not accompanying this ERS, it will be considered as ticket-less travel and treated accordingly.
- If the name of the passenger does not appear on the chart, the passenger should not board the train as he/she will be treated as a passenger without ticket and dealt accordingly.
- At the exit gate of destination station, the slip will be collected by the ticket collector.
- On demand from ticket checking staff the passenger should produce this slip along with the above mentioned photo ID. In case the passenger not carrying the slip a penalty of Rs 50/- per ticket is liable to be charged and an excess fare ticket to that effect will be issued in lieu there of,by the staff.

**For cancellation and Refund:** The User who booked this ticket should access the website [www.irctc.co.in](http://www.irctc.co.in) for cancellation. Cancellation is permitted on the website up to the time of chart prepration.Cancellation is not possible on counters. For all other cases of claims/refunds/contingencies on this ticket, the registered users may send their claims in detail by email to IRCTC at [etickets@irctc.co.in](mailto:etickets@irctc.co.in). IRCTC will process the claims with Railways and on receipt of refunds from Railways, will credit the same back to the customers account.Cancellation and refund of this ticket are governed by Indian Railways Cancellation Rules.

A flat refund of 25% of total fare charged on ticket,excluding Tatkal Charges is granted on cancellation of confirmed Tatkal tickets, which are cancelled up to 24 hrs. before the schedule departure of train. No refund on confirmed Tatkal tickets when cancelled within 24 hrs.of the schedule departure of train. For contingent cancellation & waitlisted Tatkal ticket cancellations,charges will be deducted as per existing Railway rules.
