YOU HAVE THE RIGHT TO CRITICIZE THE POLITICAL PHILOSOPHY OF ZIONISM.

- It is not Anti-Semitism -

This is a GUARANTEED RIGHT OF DEMOCRACY.

It is NOT ANTI-SEMITISM to criticize GOVERNMENT POLICY & POLITICAL PHILOSOPHY.

The Religion of Judaism is not ISRAELI GOVERNMENT POLICY & ZIONIST PHILOSOPHY

Religions & Nations are different by definition, And Church & State should be kept separate.

THUS, Many Jews are critical of the policies & actions of the Israeli Government. ... and Many Jews consider the policies & actions of the Israeli Government to be IMMORAL ACCORDING TO JUDAISM - their religion.

IRONICALLY, Many Jews believe that associating Judaism with the policies & actions of the Israeli Government actually increases resentment & anger toward Judaism, WHICH ACTUALLY INCREASES ANTI-SEMITISM.

<u>IN FACT</u> – often the accusation of Anti-Semitism toward Israel's critics are actually making that accusation to suppress criticism (inhibit Free Speech – another Democratic Right) because the accusers can't make substantial rebuttal in Israel's defense, SO THEY ARE ACTUALLY TRYING TO SUPPRESS FREEDOM OF SPEECH.

IN FACT & IRONICALLY – The Zionist Organizations that started the State of Israel are ethnically closer to being Caucasian European.

.... And the Palestinian Arabs whom they are oppressing and exploiting are actually true Semites having lived in Palestine for over 2000 years.

So ... who is REALLY being Anti-Semitic ?

(NOTICE – these are about Government Policy & Practice, and not about Criticism of a Religion, and Religious Belief & Practice)

1. Examination of ISRAELI LAWS & COURT RULINGS shows that Israeli Government practices RACIST DISCRIMINATION.

This is an UNAVOIDABLE RESULT of trying to be a Jewish State – a State special for one group over all others, giving special privileges to one group over all others.

Examination of International Law shows that this System of Discrimination NOW ... <u>fits the LEGAL DEFINITION OF APARTHEID</u>.

2. Examination of ISRAELI LAWS & PRACTICES shows that Israel is <u>NOT A TRUE DEMOCRACY if you are not Jewish</u> –

- * The Zionist Organizations that created Israel have control of the government;
- * Jewish organizations are given special positions throughout the government;
- * Freedoms of speech & association are inhibited in very clever ways.

3. Throughout its history, Israel & the Zionist organizations that created Israel <u>had to PRACTICE ETHNIC CLEANSING in order to</u> <u>create a demographic majority</u>

which they needed to create the State of Israel having a democracy only for Jews.
