Mercer, John Thomas—Appointed Lieutenant Colonel of the 4th Battn. Ga. Inf. July 19, 1861. Elected Colonel of the 21st Regt. Ga. Inf. Sept. 27, 1861. Mentioned for gallantry at battle of Gettysburg, Pa. July 1863. Killed at Plymouth, N. C. Apr. 18, 1864. Buried in Episcopal Church Yard at Tarboro, N. C.

Hooper, Thomas W.—Colonel. See Adjutant.

Morrison, James J.—Appointed Major of the 4th Battn. Ga. Inf. July 19, 1861; Lieutenant Colonel of the 21st Regt. Ga. Inf. Sept. 27, 1861. Resigned Mar. 30, 1862. Appointed Acting Lieutenant Colonel of the 1st Regt. Ga. Cavalry in 1862; Colonel May 21, 1862. Recommended for appointment as Brigadier General but tendered his resignation as Colonel, on account of ill health, which was accepted Apr. 15, 1864.

Hooper, Thomas W.—Lieutenant Colonel. See Adjutant.

*The 4th Battn. Ga. Inf. (Mercer's Battalion), was merged into the 21st Regt. Ga. Inf. on or about Sept. 27, 1861.

Glover, Thomas C.—Lieutenant Colonel. see Major.

Hooper, Thomas W.—Major. See Adjutant.

Glover, Thomas C.—Major. See Captain, Co. A.

Lynch, Michael—Major. See Captain, Co. I.

Hooper, Thomas W.—Adjutant in 1861. Elected Major Sept. 27, 1861; Lieutenant Colonel Mar. 30, 1862; Colonel Apr. 18, 1864. Captured at Winchester, Va. Sept. 19, 1864. Released at Fort Delaware, Del. July 24, 1865.

Verdery, Thomas J.—Adjutant. See 1st Lieutenant, Co. D.

Bakewell, Lea F.—Adjutant June 4, 1863. Roll for Aug. 31, 1864 last on file, shows him present. No later record.

Haslett, William—Chaplain May 21, 1862. Resigned, disability, Aug. 18, 1863.

Barton, Benjamin P.—Sergeant Major. See 3d Sergeant, Co. C.

Rowland, Samuel J.—Sergeant Major. See 3d Sergeant, Co. F.

Duke, William J.—Sergeant Major. See private, Co. D.

Hall, James E.—Acting Sergeant Major in 1865. See private Co. B.

Hood, Donald M.—Quartermaster July 19, 1861. Resigned, disability, Mar. 9, 1863.

Whitlock, Andrew J.—Assistant Quartermaster Apr. 5, 1863. Surrendered, Appomattox, Va. Apr. 9, 1865.

Dawson, Lemuel Hawk—Quartermaster Sergeant. See private, Co. F.

Danforth, William M.—Quartermaster Sergeant Feb. 1, 1862. See private, Co. A.

Hoover, George F.—Quartermaster Sergeant Apr. 1, 1863. See 3d Sergeant, Co. G.

Darden, George—Ordnance Sergeant May 1, 1862. See Commissary Sergeant.

Rowland, Samuel J.—Ordnance Sergeant Apr. 20, 1864. See 3d Sergeant, Co. F.

Holt, Cicero—Appointed Surgeon, C. S. A., Apr. 17, 1861. Assigned to duty with the 21st Regt. Ga. Inf. Resigned Feb. 20, 1862.

Gott, Louis E.—Surgeon Mar. 9, 1863. Surrendered, Appomattox, Va. Apr. 9, 1865.

Capers, LeGrand G.—Assistant Surgeon July 19, 1861. Appointed Surgeon. Transferred Nov. 1863. Serving as Surgeon of Cutshaw's Battn. Artillery Apr. 1, 1865. No later record.

Cowherd, Colby—Assistant Surgeon Sept. 13, 1861. Transferred to the 12th Regt. Ga. Inf. as Assistant Surgeon. Surrendered, Appomattox, Va. Apr. 9, 1865.
