A Note from the President

Remember that the November meeting will be on the second Tuesday and not the first Tuesday. The first Tuesday is Election Day. Many of us will be occupied as election judges and thus not available for a meeting. As always, this is an important election.

While the top of the ballot has excited many individuals, it is not the only contest. We will be electing a U.S. Senator and eight U.S. Representatives. We will be electing 68 State Senators and 134 State Representatives. State Supreme Court Justices will also be on the ballot as well as some county judges. Other county races could include water district commissioners and other offices. Finally, there will be the Constitutional Amendment that we heard about at our last meeting.

Before you enter the polling booth, do your homework. Find out about candidates' past voting records. Go to legislative forums and ask questions about what concerns you. Read their position papers. Don't rely on radio and television ads, they are often intentionally misleading.

As an environmental organization, the Audubon Chapter of Minneapolis urges you to support candidates that protect habitat, support clean water, keep OHV's on trails, support sustainable living and protect all our natural resources. We are facing financial hard times and thus we must select candidates who will represent us responsibly once elected. Some of our priorities may have to be delayed; however, many of our issues cost nothing and should be implemented as soon as possible. So vote as a well-informed voter!



And while you are in a community-minded spirit, ask to be on the Audubon Chapter of Minneapolis Board. We need you!

November Program

Bringing Back the Bobwhite Quail

The founder of the Bobwhite Quail Society will be the featured speaker at the November's program of the Audubon Chapter of Minneapolis.

Thurman Tucker started the organization because he saw that the bobwhite was drastically declining in Minnesota. His presentation will provide a description of the bobwhite, its habitat needs, what his organization and others are doing to bring back its numbers, and what we all can do to help.

A native of Tennessee, Thurman developed his interest in bobwhite quail on his grandfather's farm. He came to Minnesota in 1965, attended the University of Minnesota, and went on to own his own grocery store in Minneapolis for many years. Besides his work with the Bobwhite Quail Society, he currently serves as president of the southeastern Minnesota Quail Forever Chapter, where Minnesota's bobwhite population is primarily located.

He will talk about his work with a number of enthusiastic members who share his interest and hold annual banquets to raise funds, contact farmers, and build habitat on farms. The students in the neighboring high schools have been making quail feeders, and helping to develop acreage for bobwhite, using quail management techniques. Currently, the Bobwhite Quail Forever Chapter of southeastern Minnesota is centering its efforts in Houston and Fillmore counties around the 10-year set-aside federal program known as "CP 33," which is specifically designed to help improve bobwhite quail numbers.

Tucker lives in Minneapolis with his wife of 38 years and travels to southeastern Minnesota on a regular basis. He says chasing after the birds will keep him forever young.



Red-headed Woodpeckers and Waterfowl

Time: 8:30 a.m.— 11:30 a.m.

Meet: Cedar Creek Ecosystem Science Reserve, Anoka County, MN (Fish Lake Trail)

Directions: From SH 65, turn east onto 237th Ave. NE at Cooper's Corner in East Bethel. At T intersection, turn right (sign for Cedar Creek HQ points left). Follow this road (Gopher Dr.) as it heads south, then becomes 229th Ave/ CR 26 as it heads east. At stop sign, turn left onto Durant St.; follow dirt road to right to Fish Lake Trail parking area. Portable toilet available.

A good chance to see some of the few remaining nesting red-headed woodpeckers in Anoka County. We'll also check for migrating waterfowl and resident otters at Fish Lake.

Cranes Seen and Heard

It paid off to be an early birder on our Sept. 27 sandhill crane field trip. We were able to get very close to a sandbar in the Sherburne National Wildlife Refuge by driving into an area normally closed to the public. Refuge manager Anne Sittauer and Anoka County resource specialist Tim Sevcik led the 6:00 a.m. trip to watch and listen as hundreds of cranes took flight at dawn. We also spotted trumpeter swans, white pelicans, wood ducks, mallard ducks, Canada geese, pied-billed grebes, bald eagles, large flocks of red-winged blackbirds, a kingfisher, and a very cooperative marsh wren..

Project FeederWatch Benefits Birds and People

Studies have shown that an association with nature reduces stress and promotes a feeling of well-being in adults and children.

For twenty-plus years, the Cornell Lab of Ornithology has sponsored Project FeederWatch, which gets underway on November 8 for the 2008-2009 season.

Participants count the number of birds at their feeders each week and submit their information to the Cornell Lab. The data of bird sightings, winter movements, and range shifting help scientists monitor the health of birds and the environment and contributes to the largest database in the world on feeder-bird populations.
