So for those of you who are coming in the night before and setting up be aware of where the show tables will be set up so that we **DO NOT** have to move the animals in the morning.

## Show Rules

1. All ARBA classes may be entered and shown.
2. Youth cannot enter same rabbit in both open and youth.
3. SRR&CC reserves the right to refuse any entry.
4. Each exhibitor is responsible for getting their own animals to and from the show table promptly. If animal is not brought up to table within the three call minimum it will be scratched.
5. There is to be no interference with the judge's placement of any animal, no talking across the table to the judge by the exhibitor, unless the judge so directs. If there is any interference, the exhibitor shall be asked to leave and shall forfeit their entry fees.

6. This is a one day solid bottom carry cage show. Only towel, wood pellets, or paper pellets may be used as bedding, or carrier fill. No straw, shavings, or other loose bedding material.
7. SRR&CC or show facilitators will not be held responsible for loss due to fire theft, accident or destruction. All precautions within reason will be taken.
8. SRR&CC reserves the right to substitute judges.
9. By filling out and signing the entry form, the exhibitor agrees to abide by these show rules, and all ARBA rules.
10. Each exhibitor must verify their entries prior to the show starting.

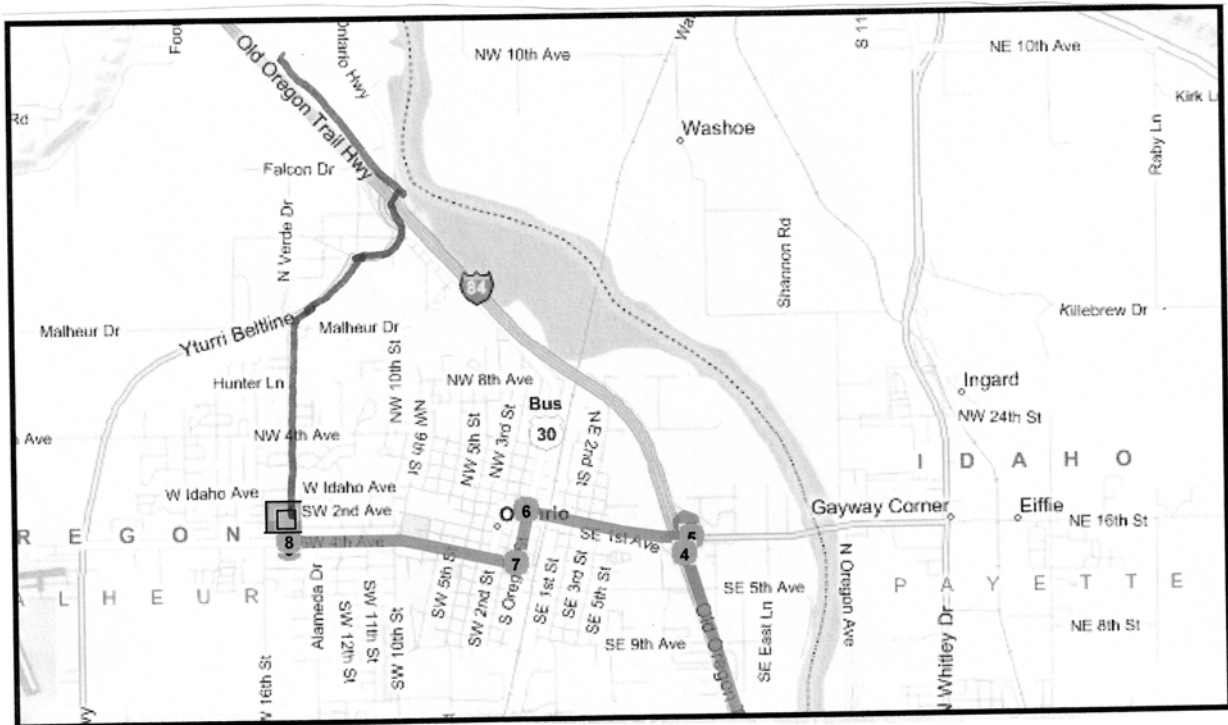
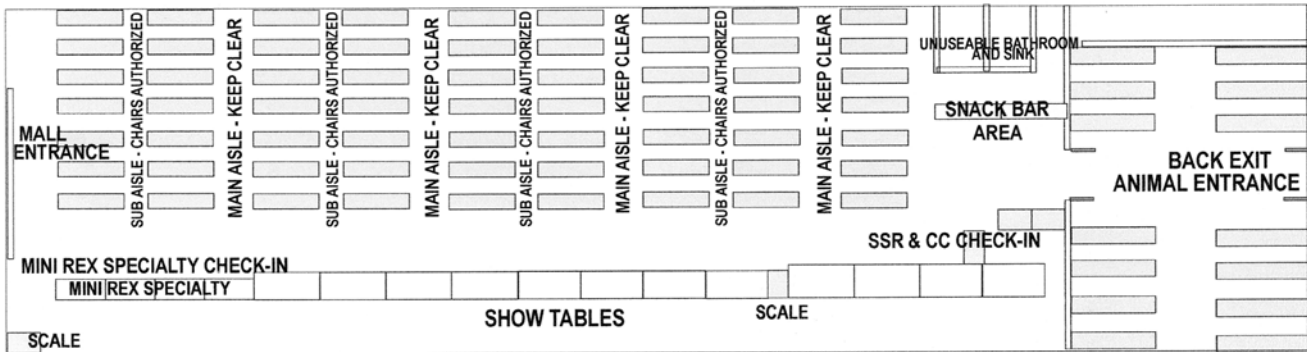
