2. The promotion of the above officers is further subject to the following terms and conditions:-

- i) They have been absorbed in BSNL on permanent basis.
 - ii) No disciplinary /vigilance case is pending against him and no VC is withheld in the terms of instructions contained in GOI (DOP&T) OM No.- 22011/4/91- Estt. (A) dated 14.09.1992.
 - iii) The currency of any penalty against the officer is over; or
 - iv) The officer is not on deputation to TCIL or any other organization.
- 3) BSNL corporate will decide such above detailed in above Para on receipt of information from concerned SSA/Units. Information in this regard may be brought to the notice of this office immediately and the concerned officer should not be promoted or relieved for posting without specific orders from this office.
- 4) JTOs, who have opted for DoT or who have not given option for their absorption may not be promoted. Such cases may be reported to this office.

- 5) All Heads of SSAs concerned may please ensure that the promotion/posting orders in respect of above officer found eligible after fulfilling the above conditions are issued in time to enable to join his promotional assignment within 40 days (including joining time) from the date of Issue of BSNL HQ order no. 2-15 / 2009 Pers.II dated 15.05.2009. Accordingly, the officer is required to join the promotional assignment within the prescribed time limit.
- 6) In case the officer concerned fails to join the promotional assignment within the prescribed period of 40 days, he should not be allowed to be relieved or join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for modification of promotion order shall be entertained.
- 7) Heads of SSAs/Units concerned are further directed that the pending request of the officer for modification of the promotion / posting orders can not be taken as a ground for holding of the implementation of the promotion orders in respect of the officer.
- 8) The leave, if any, requested by the officer who has been posted on promotion in different SSAs / Units should not be allowed. If any officer desires leave, he/she can apply leave to new SSA/Unit under whom he/she has been posted only after joining new post and new SSA/Unit will sanction leave, if it is considered justified in normal course.
- 9) The date on which the above order is given effect to may be intimated to this office and a consolidated report of the officers who have been relieved /have joined their new postings may also be sent immediately on expiry of 40 days from the date of issue of BSNL HQ order no. 2-15 / 2009. Pers.II dated. 15.05.2009. Charge reports may be submitted to all concerned.
- 10) The aforesaid promotion order is provisional and is subject to outcome in of final decision in any lawsuit(s) pending before any court(s) regarding their regulation of seniority/promotion.
- 11) The particulars of officers may also please be updated in the HRMS as soon as they join as SDE(T) on the basis of this order.
