1.0 Introductory Business

The meeting opened at 8:15 pm and the apologies were noted.

1.1 President's Welcome

President Peter Smith opened the meeting at 8:00 pm and welcomed those present.

1.2 Minutes of the Previous Meeting

The Secretary noted that the Minutes of the Sunset Soaring Club AGM for 2006 were not available on the club website, and instead briefly outlined a summary of the decisions which were distributed in an email to members on 26 March 2006. The nominees accepted the positions and as there were no other nominations, they were declared elected.

4.0 General Business & Discussion

4.1 New Council Ranger means we must now always put out the safety cones:

Peter noted that the new Council Ranger is visiting often and is being much tougher on dog owners who disobey council regulations on walking dogs off-leash. He is friendly but is also strict about our hours of hire. He expects the cones to be out while we are flying, and when he finds anyone flying at the field during non-hire times he stops them and recommends that they join the club and fly only during club hours. In order to retain good relations with the new Ranger and in view of recent confrontations with members of the public, it was agreed that Club members should now always put out the cones during club hours, even if there are only one or two members present.

4.2 Bids for Government Funding in 2007-8:

Robin noted that he and Phil put in a lot of effort in 2006 to bid for training equipment from the Federal Government's Volunteer Small Equipment Grants (VSEG). We were also considered for a grant in 2007 from the same submission but we were ultimately unsuccessful.

Robin suggested bidding for limited tree planting and new bench seating in and around the pits area, which would also be of benefit to the general community. It was pointed out that such bids normally require a 50% funding contribution from the club, which we probably could not afford. Normal council maintenance funding may cover the replacement of the existing seats which are in bad condition. Tim Wooller agreed to pursue further information on this at the May Council meeting.

4.3 **Decision on allowing Lithium Ion cells deferred to next meeting:.**

Andrew suggested that we should re-word and clarify the clause in the code of conduct that refers to LiPo "balancing circuits" – it should instead refer to cell balance adapters used with LiPo chargers. It was also pointed out that we should clarify the status of Li-Ion cells which are currently effectively banned. With balance adapters they should be allowed.

It was decided to defer discussion on Li-Ion until the next show-& tell meeting and to call on the knowledge of Mike O'Rielly.

4.4 **High power bungee launching 3m+ gliders to be allowed on a trial basis :**

There was general discussion about recent activities launching gliders over 3 m in wingspan, including the "human-runner" harness and pulley system for high-powered bungee launches. These large gliders cannot be launched with the club's standard bungee.

Several members expressed great concern about the danger of the extra people this system requires on the field during normal powered and glider activities.

Higher powered conventional bungees suitable for up to 4 m gliders are available from our current bungee supplier for about US\$125, compared to the US\$85 for our current 2m bungee. Mike O'Rielly has stated that he may purchase his own 4m bungee, but has asked the club to consider purchasing one. No decision was made on this purchase.

It was finally moved that: "High powered pulley launch of gliders of greater than 3 m wingspan will be permitted at the Golden Jubilee Field for a trial period of six months, providing that the operations does not cause disruption to the club's normal flying activities."

Moved: Barrie, 2nd: Robin – Carried.

4.4 **Ban remains on electric helicopter operations:.**

There was general discussion about another request to operate electric helicopters at the field. Associate members from Warringah Radio Control Society described their experiences with the disruptive nature of helicopter operations at their club. There was general agreement that we have no suitable location at the field for helicopter operations, and that allowing it would cause disruption to normal electric powered and glider flying activities. Our ban on helicopter operations therefore remains.

4.5 **Recommended club trainer aircraft should include Multiplex Easy Glider:**

There was general discussion about the most suitable trainer aircraft for new young members. John Ellis recommended the bungee-launch Easy Glider for under -12 year-olds, because of its low cost and simplicity (no speed controller, motor batteries or charger required). There was general agreement but no motion was moved or carried.

4.6 **Request for topic ideas for Show & Tell meetings:**

Peter Smith asked for ideas and volunteers for the next Show & Tell meeting. Ideas submitted included:

- Tom Schaeffer to be asked to present on his work with Barrie on using CAD/CAM to cut a kit for Barrie Hill's "Bazza 15" sports aerobat design.
- Peter Smith on what's available from new Hong Kong RC model suppliers United Hobbies.
- David Lietch to be asked to present on competition and thermal glider flying
- Les Smith on operating and basic uses of a multi-meter
- Someone to present on slope and dynamic soaring techniques
- Someone to present on using Motocalc
- Someone to present on basic aerodynamics
- Someone to present on how to build an EasyStar

Anyone willing to present on any of these topics should contact Peter Smith.

4.7 **C-Tick certification required for any 2.4 GHz transmitter covered by MAAA insurance:**

There was general discussion about the growing controversy about Model Flight's control of the Spektrum 2.4 GHz market via it's use of the C-Tick mark and MAAA insistence that only transmitters with Model Flight's C-Tick will be covered by insurance.

Members were warned that until this is resolved it would not be wise to operate Spektrum equipment imported from overseas retailers, as if they have an accident they may not be covered by MAAA liability insurance.

Major Activities

- Correspondence - 125 emails in, 80 sent, 10 letters received, 16 sent
- 2006 FACSIA VSEG bid for training equipment - Thanks to Phil Stanley
- We made the short list, but the VSEG Grant was ultimately unsuccessful
- Now have four qualified and MAAA certified Instructors (2 are members)
- Members grew from 39 in 2005, to 44 in 2006 and now 57 in 2007
- Largely thanks to the website & our volunteer instructors and trainers
- Only 8 members have qualified for Bronze Wings and 3 for Gold Wings, so a major aim for 2008 is to encourage more members to qualify.
