

## I accuse of negligence in the research and information related to the use of stage hypnosis in crimes

I'm fulfilling my social responsibility reporting it to the community.

These criminals usually get their victims to steal and get they be accused for the crimes, to violate or kill their own child, to separate couples, to get their victims lost their jobs, etc. His work is easily identifiable, if one day they decide to attack you, nobody will help you, and that should be enough incentive to worry about.

What means this?

If I decide to violate your wife or daughter, stole you or kill you, if I'm enough intelligent and careful, you won't have any way to protect from me, as it had happened to thousands of people. And that is the main reason why you should think seriously about it. This is not about "them", else about you and your security.

Recent cases like: Conman hypnotizes jeweler, steals 160,000 U\$ in diamonds ([http://news.yahoo.com/s/afp/20090413/wl\\_sthasia\\_afp/in\\_diacrimeoffbeat\\_20090413082745](http://news.yahoo.com/s/afp/20090413/wl_sthasia_afp/in_diacrimeoffbeat_20090413082745)) only are more to add to the list to crimes nobody does anything to prevent them.

In the reality nobody makes themselves responsible to do this prevention, this is not they don't understand or don't agree, but easily find a justification for not doing it.

The problem I wonder, if everyone accepts a serial killer, this is a truthful case, had get dressed as a clown to attract children and kidnap them for subsequently torture and kill them; Why the same people doesn't accepts the possibility the same serial killer, after seeing a show of stage hypnosis where a person is put in trance with a sudden movement and a direct order to sleep, haven't thought to use Stage Hypnosis to damage to their victims, leaving no evidence?

OR to think a thief who no doubt in nailing a knife in the back to steal you a clock, drug you to steal you an organ; mafias who traffic with drugs, children, etc., whom takes months planning their crimes, don't think about the possibility of using hypnosis to carry out their crimes, to implicate other people in crimes and have fun sadistically.

The possible causes for unreported criminals making crimes using stage hypnosis are: 1) they never thought in that idea. (2) They did, and succeeded in such a way nobody knew it.

Is difficult a crime using Stage Hypnosis? If you have seen a show of stage hypnosis, you can judge these examples by yourself.

A criminal can wait a day when his lover enters in a state of depression or stress because she has some personal problem or some problem in her work, and that night, before bedtime, place her in trance with a snap and order her to sleep, and ask her to take a glass of water and sleep, simply put a fatal overdose of tranquilizers, and the next day she appears dead, all the evidence of criminalistic give false and the criminal don't arouse suspicions, this is a suicide without doubts.

You can put into a trance to a father and his son, you order the father to open his eyes and he see a big dog real next to his son, continuing in trance you order him to close his eyes and you move his son in trance to the place the dog was, then you tell the father the dog is attacking his son, without opening his eyes, giving him the possibility to defend his son using a stick, what happens? While the father has his eyes closed he assumes the dog remains in the same place, in which his son in trance is now. Then false memories are introduced to the father, and we have a criminal. As you can see it is simple, the victims cannot protect themselves because there is no information, do not realize that they were in trance and believe that they did really, and the authorities do not consider the use of hypnosis in crimes as an option.

The previous point is controversial, but about the use of drugs like escopolamina (burundanga) no body has doubts, but there aren't measures to identify and protect about it; because victims instead of being helped, appears liked drugged and are rejected socially.

The disinformation Is mainly generated, because most people assumes someone must have thought and investigated this possibility and if they didn't inform about this kind of crimes is because it is not possible. But that is the point, no one did, there is no scientific research on Stage Hypnosis applied to the crime.

Specialists often refuse to deal this topic with seriousness and justify it on the scientific fact, entirely true, saying in trance a person don't do anything wouldn't do in reality, and you may verify it, for example when a person is in trance if you ask him to kill a person, have sex, dispose his money or do any other thing he wouldn't do in reality, HE WILL NOT; and that is totally true; BUT, the complete

assertion is in trance a person don't do anything he wouldn't do in reality, IF you don't distort previously the external reality (he must protect his young son in the car from intense cold, where in fact he will die of heatstroke), IF you don't distort the personality or age, IF you don't distort the emotional circumstances he is living, IF you don't nullify mental functions, IF you don't give drugs or specific natural foods to alter the mind momentarily, IF the suggestions aren't generated in the name of an authority, IF you don't kill him mentally, this means to live an episode in trance where he ends dying according to his mind. IF he is not exposed to other activities prior to do more suggestible and deplete mentally, having sex into a trance and don't allow him to sleep.

Real Cases There are proven cases, for example about a decade ago there was a robbery, subsequently accepted as a crime using hypnosis and drugs by the police in the US in which a woman had to be discussing months with researchers, psychologists and policeman (all believed she was mad), to get them to accept the possibility that criminals doped and hypnotized her, and get her to go to the bank and take their money to give it to the criminals without any resistance. Finally she demonstrated that it was true; but so far nobody had taken any proactive position to detect crimes in which had been used Stage Hypnotism; normal people are not informed so they can protect themselves neither inform to police departments so they know about it.

Using simple logical deduction, criminals who committed this error will not commit again, these techniques have already been taught to other criminals, and how many do you believe had learned in 10 years?

Some facts demonstrated on hypnosis Some facts investigated by several recognized authors:

-Is very easy to learn stage hypnosis and you only need to practice to put a person in trance giving the hand and ordering to fall asleep. In fact it is so easy to put in a trance to certain persons, that in televised presentations of stage hypnosis, some viewers are also put in trance and Stage Hypnotist should provide suggestions to get them leave trance also.

-While more intelligent is a person is easier to hypnotize.

-The state of trance is a state, where the body is relaxed and the mind blank, is not an abnormal sensation. People who are often hypnotized, can't recognize they are in

trance, because the state of trance is a state of mind and feeling very similar to the living day to day; in fact studies suggest that several times during the day, when you do certain tasks and during the night, our mind enters a state similar to that of trance by moments.

-In trance is possible to introduce false memories, remember something didn't happen in reality.

-If you program a person in trance, every time he sees a tree to feel tired; every time he see the tree will tend to enter mentally in a state as he was when he was received the suggestions, this means mean while you reprogram more and more objects, parts of the body, sounds, etc. These triggers push your mind to state close to the trance.

-There are no persons who may not be hypnotized, when a person has resistance and problems that prevented him from entering in trance; experience has shown that simply persisting will put him into a trance.
