EXPIRATION OF PERMIT: A building permit remains valid for two(2) years as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A BUILDING PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN 180 DAYS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED BUILDING PERMITS CANNOT BE REFUNDED. THE CHARGE TO RE-OPEN A CLOSED BUILDING PERMIT IS 30% OF THE ORIGINAL PERMIT FEE.
