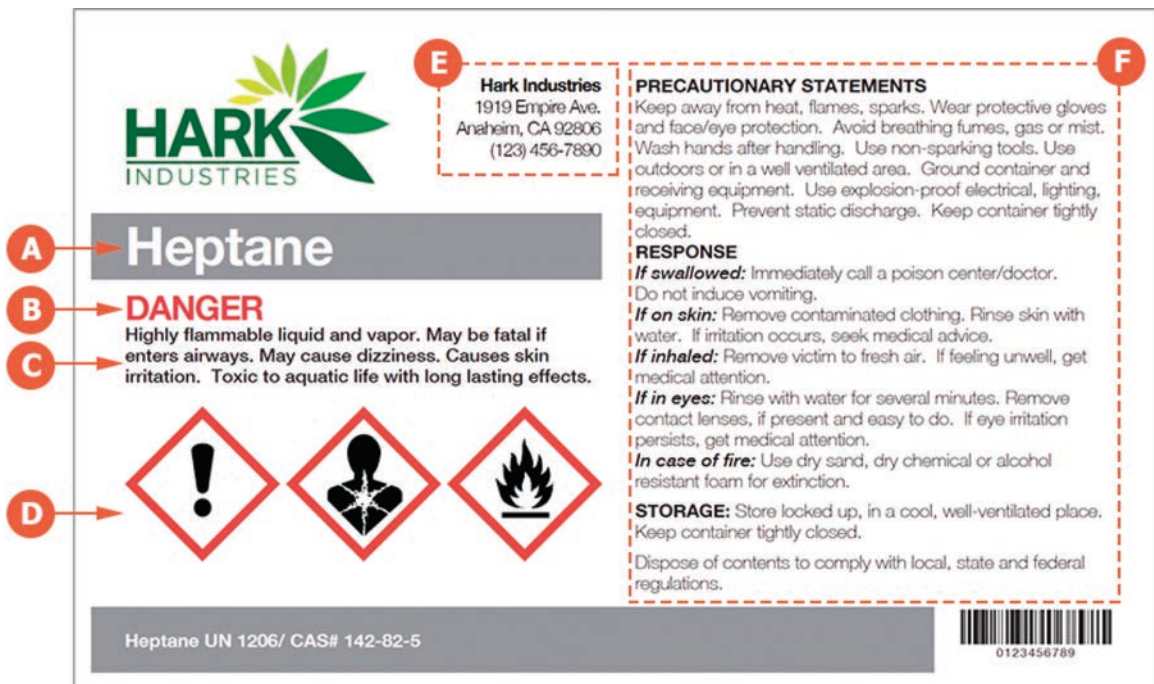

§ 22 TREASON; DEFINITION, EVIDENCE.

SEC. 22. TREASON AGAINST THE STATE SHALL CONSIST ONLY IN LEVYING WAR AGAINST IT OR IN ADHERING TO ITS ENEMIES, GIVING THEM AID AND COMFORT. NO PERSON SHALL BE CONVICTED OF TREASON UNLESS UPON THE TESTIMONY OF TWO WITNESSES TO THE SAME OVERT ACT OR ON CONFESSION IN OPEN COURT;

HEREIN AND THEREAFTER; PROCLAIMED AS SUFFICIENT EVIDENCE PURSUANT TO 10 USC § 1044 A WITH SAID STIPULATION OF UTTERANCE AND ACTS IN FURTHERANCE OF 18 USC 2381 - 2387 IN SITU AND IN PROPAGATION; THEREAFTER ADJUDICATION WITHHELD; BY EXISTENCE AND JURAT OF 18 USC 2381 - 2382; AS FOLLOWS:

18 U.S. CODE § 2381 - TREASON - WHOEVER, OWING ALLEGIANCE TO THE UNITED STATES, LEVIES WAR AGAINST THEM OR ADHERES TO THEIR ENEMIES, GIVING THEM AID AND COMFORT WITHIN THE UNITED STATES OR ELSEWHERE, IS GUILTY OF TREASON AND SHALL SUFFER DEATH, OR SHALL BE IMPRISONED NOT LESS THAN FIVE YEARS AND FINED UNDER THIS TITLE BUT NOT LESS THAN \$10,000; AND SHALL BE INCAPABLE OF HOLDING ANY OFFICE UNDER THE UNITED STATES.
