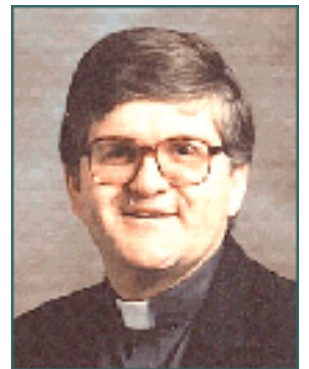

DIRECTIONS to the PPMC (See map below or visit <http://www.geocities.com/pilgrimsfaith/PFMCDir.pdf>)

From the NORTH or NORTHWEST

Get on **NEW JERSEY (NJ) Highway 73 SOUTH** towards **Marlton** and **Berlin**. From the **NJ TURNPIKE** use **EXIT 4** then stay left to join **NJ Highway (NJH) 73 SOUTH** towards **Marlton** and **Berlin**. Follow **NJH 73 SOUTH** for several miles until you see **KOHL'S** on your **RIGHT** in a shopping center. You are approaching the intersection of **NJH 73** and **NJH 70**, called the **Marlton Circle**. **NJH 73** traffic passes through the center of the **Marlton Circle** with **NJH 70** traffic passing around the circle. Take note of when you pass the **NJH 70** intersection (**OLGA'S DINER** is on far right corner) and **START COUNTING TRAFFIC SIGNALS** on **NJH 73 SOUTH** after you leave the **Marlton Circle**.

After the **EIGHTH TRAFFIC SIGNAL**, **Lakeside Avenue / Signal Hill Drive**, get in the **LEFT** lane for a **LEFT TURN** at the **NINTH TRAFFIC SIGNAL** with **NIAGARA POOLS** to the **LEFT**. Turn **LEFT** onto **COOPER ROAD, CAMDEN COUNTY HIGHWAY (CCH) 575** (Gold letters on a Blue Pentagon Sign).

Proceed 3/10 mile to 61 Cooper Road, which is the second house on the right after the **Verizon** complex. Turn **RIGHT** into the driveway and park as far back on the property as possible. **Enter the blue sided addition** by the closest door and proceed to the **PPMC** offices located on the first floor.

From the SOUTHWEST or SOUTH

If using the **NJ TURNPIKE**, it is easiest to go to **EXIT 4** and follow the directions from the **NORTH** or **NORTHWEST**.

If using **INTERSTATE (I) – 295**, take **Exit 32** for **CCH 561** (Gold letters on a Blue Pentagon Sign) which is called **HADDONFIELD – BERLIN ROAD**. Go **EAST** towards **Berlin** (There is a **Melita Coffee** operation to the right of the exit ramp which is just beyond the **Exit 31** ramps going to and coming from the **Woodcrest Rail Station**.) Follow **CCH 561 EAST** until it intersects with **NJH 73** at the **BERLIN CIRCLE** (**Palace Diner** and **McDonalds** counter-clockwise on two of the four corners). This is about six miles from **I-295**. Go 270 degrees around the **Berlin Circle** and go out onto **NJH 73 NORTH**. Follow **NJH 73 NORTH** to the third traffic signal (**WENDY'S** on the **LEFT** and two traffic signals past the **Wal-Mart**) and turn **RIGHT** onto **COOPER ROAD, CCH 575**. Follow “**Proceed 3/10 mile . . .**” above.

From the SOUTHEAST or EAST

From **NJH 73 NORTH** or any other route that brings you to the **NJH 73** and **UNITED STATES (US) HIGHWAY (USH) 30 INTERSECTION** between **Berlin** and **Atco**. Follow **NJH 73 NORTH** of **USH 30** and go under the **RAILROAD OVERPASS** to turn **RIGHT** on **CCH 534** which is labeled **JACKSON ROAD**. Follow **CCH 534 EAST** one block to the first traffic signal and turn **LEFT** onto **TAUNTON ROAD** just before the **TOWN TAVERN**. Follow **TAUNTON ROAD NORTH** about three blocks to the second **LEFT** turn marker and turn **LEFT** onto **COOPER ROAD, CCH 575**. Follow **COOPER ROAD, CCH 575**, about 3 miles, past the four way **STOP SIGNS** at **TAUNTON ROAD** to the **PPMC** at **61 COOPER ROAD** on the **LEFT** just before **NJH 73**. Watch the traffic turning **LEFT** into the community across the street from the **PPMC**. Turn **LEFT** into the driveway and park as far back on the property as possible. Follow “**Enter the blue sided addition . . .**” above.

From the NORTH or NORTHEAST

From **NJ HIGHWAY 70 WEST** or any other route that brings you to **Medford Village** and the intersection of **NJH 70** and **BURLINGTON COUNTY HIGHWAY (BCH) 541** (Gold letters on a Blue Pentagon Sign). Follow **BCH 541, Main Street, SOUTH** through **Medford Village** until it crosses a concrete bridge with parkland on either side. Turn **RIGHT** onto **BCH 623, Mill Street**, and follow until it ends at the junction with **BCH 544 EAST**. The above will require a **RIGHT** turn when **Mill Street** ends and a bear to the **LEFT** at the next traffic signal with **HARTFORD ROAD** coming from the **NORTH**.

At the junction with **BCH 544 EAST** (about 3 miles from **Hartford Road**, through the traffic signal at **Tuckerton Road, BCH 620**) there is a traffic signal with a **7-11** and **Blockbuster** ahead. Turn **LEFT** and then bear **RIGHT** onto **HOPEWELL ROAD**. Follow **HOPEWELL ROAD** about 3 miles to a **FIRE STATION (FS)**, turn **RIGHT** onto **CHESTNUT ROAD** just past the **FS**. At the end of **Chestnut Road** turn **RIGHT** onto **KETTLE RUN ROAD**. Go one block on **Kettle Run Road** and turn **LEFT** onto **SYCAMORE ROAD**. There is a name change to **TAUNTON AVENUE** in **Camden County**. Continue to first intersection, **COOPER ROAD, CCH 575**.

Turn **RIGHT** at the four way **STOP SIGNS** onto **COOPER ROAD, CCH 575**, and proceed about 1 mile to the **PPMC** at **61 COOPER ROAD** on the **LEFT** as you approach the traffic signals on **NJH 73**. Watch the traffic turning **LEFT** into the community across the street from the **PPMC**. Turn **LEFT** into the driveway and park as far back on the property as possible. Follow “**Enter the blue sided addition . . .**” above.
