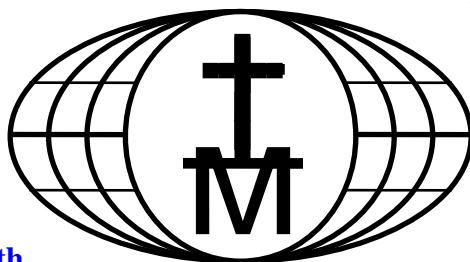

Any **ministry or vendor table requests not made in advance, with confirmation, may not be accommodated on the day of arrival**. Please be as accurate as possible in expressing your needs, especially electricity and phone lines, as tables must be positioned near power or phone outlets for these special services to even be available.

All **ministry / vendor display applications** must include all information including names, address, city, state, zip, phone, fax, and e-mail, if available. All persons coming with a **ministry or vendor** must fully register for the desired events and those not covered by table charges must donate for their registration. Dates of each person's attendance must be stated in advance and respected as much as feasible.

Other ministry / vendor displays will NOT include priced material displayed by the PFMC in the Regency Ballroom.
